



Service Specifications

- Services are delivered within the Adelaide PHN region
- Services can only be provided by Adelaide PHN Commissioned Service Providers
- Residents must satisfy the Eligibility Criteria
- RACFs must be a Registered Site to access services for residents

Roles and Responsibilities Mental Health Service Providers

- Provide evidence-based low intensity and short-term psychological therapy appropriate to resident needs delivered by appropriately qualified mental health professionals
- · Communication and feedback to RACF and GP
- Upskill RACF staff to identify and better manage mental health issues in residents

RACF

- Identify and refer residents who are eligible for and may benefit from the mental health services
- Facilitate GP involvement and arrange medical review (if indicated) to exclude physical illness, severe cognitive impairment or other organic causes (e.g. delirium)
- Assist residents to attend appointments
- Provide access to information about resident's medical history relevant to mental health treatment
- Communication with resident's substitute decision maker/s and/or family
- Promote the service to residents, families, staff, GPs and others as relevant
- Provide access to options for private space for the delivery of individual psychological sessions or group interventions

Eligibility Criteria for Residents

- be "at risk" of mild to moderate mental illness (defined as experiencing early symptoms and assessed as at risk of developing a diagnosable mental illness over the following 12 months)
- have a diagnosed mental illness, with mild to moderate symptoms of a common mental illness
- have a diagnosed mental illness, which is severe in nature, and will benefit from shortterm psychological therapies*

Exclusions

- Dementia with severe cognitive features
- Delirium

*The services will not be able to support residents with severe, persistent, and complex mental illness, who are receiving specialist care, or which would be more appropriately managed by Older Persons Mental Health Services (OPMHS).

Adelaide PHN Central Referral Unit

 Receive and process referrals from GP & Old Persons Mental Health forward to the appropriate mental health service provider according to the Step of Care required

Mental Health Service Provider – Clinical Triage

- Determine resident suitability for services
- Match resident needs to intensity and Step of Care

Mental Health Service Provider Onsite Clinical Assessment

Conducted if further investigation is required to complete triage

Mental Health Service Provider - Services

- Low intensity/psycho educational group sessions
- Short-term psychological therapy individual and/or group sessions

Referral

- RACF nursing staff, allied health professionals and family may refer directly to the low intensity/mild to moderate service. Self-referral is also accepted
- GPs and OPMHS can refer to the severe mental illness service through the APHN Central Referral Unit, via Secure Messaging HealthLink EDI: adphncru ReferralNet/Argus ID: CRU or Fax 1300 580 249

RACF registration
